

**THE SELLING NETWORK, INC. (d/b/a SAVIE)**  
**REFERRAL PARTNER AGREEMENT**

This agreement is between The Selling Network, Inc., a Delaware corporation doing business as Savie (“Savie”), and the Referrer identified below.

## 1. REFERRAL CODE & PROGRAMME

Savie will assign the Referrer a unique, single-word uppercase code (the Referral Code). The Referrer may share this code to invite new users to The Selling Network, Inc. The code is personal to the Referrer and may not be sold, transferred, or used by anyone else for commercial gain.

## 2. PAYOUTS

The following payments apply per qualifying referral, subject to the caps and conditions in sections 3 and 4:

Payout	Condition
<b>Base — \$5</b>	A new user signs up using the Referral Code and posts their first qualifying listing.
<b>Activity Bonus — \$10</b>	That same user posts 5 or more qualifying listings within their first 7 days of registration AND before the contract expires.
<b>Milestone Bonus — \$200</b>	The Referrer reaches 100 qualifying referrals in a calendar month AND every one of those users individually earns the Activity Bonus.

## 3. WHAT COUNTS AS A QUALIFYING REFERRAL

**New user:** The referred person must not have previously held a Savie account. If they connect a marketplace account that is already linked to any other Savie user, they do not qualify as a new user.

**Qualifying listing:** An item of clothing or apparel accessory (i.e. an item designed to be worn or carried on the body — such as bags, belts, hats, scarves, jewellery, sunglasses, or footwear) posted for sale on Savie that successfully lists to at least one connected marketplace. Household goods, electronics, media, and furniture do not qualify. Savie has final say on whether an item qualifies.

**Monthly cap:** A maximum of 100 qualifying referrals per calendar month will be paid out. This cap applies to all payouts combined (Base and Activity Bonus). Savie will notify the Referrer when the cap is reached.

## 4. PAYMENT

- All amounts are paid in gift vouchers — Referrer’s choice of Depop, Goodwill, or Amazon.

- Payment is issued within 7 days of the end of the contract term.
- Referrer must confirm voucher preference within 5 days of the contract end. If no preference is received, Savie will issue an Amazon voucher by default.
- Once a voucher is issued, Savie's payment obligation is fully discharged. Savie is not responsible for third-party voucher terms, restrictions, or expiry.

## 5. CONTRACT TERM

This agreement runs for 30 days from the Effective Date and then expires automatically. Savie may terminate this agreement immediately if the Referrer engages in fraud, artificially inflates referral counts, makes false claims about Savie, or breaches any term of this agreement. In the event of termination for cause, Savie may withhold all unpaid amounts.

## 6. REFERRER OBLIGATIONS

The Referrer agrees to:

- Promote Savie honestly and in accordance with applicable advertising laws.
- Not use paid advertising to promote the Referral Code without Savie's prior written consent.
- Not engage in spam, self-referral, or any other artificial inflation of referral numbers.
- Not make misleading or exaggerated claims about Savie or its platform.
- Not make any disparaging, defamatory, or negative public statements about Savie, its platform, employees, or business — during or after the contract term.

## 7. FRAUD & DISPUTES

Savie's tracking systems are the sole source of truth for referral counts and eligibility. Savie reserves the right to withhold or reclaim any payout where fraud or manipulation is reasonably suspected; where Savie exercises this right, it will notify the Referrer in writing and allow 5 business days for a response before making a final determination. Disputes must be raised in writing within 14 days of the payment summary being issued. Savie's determination is final.

## 9. LIABILITY

Savie's total liability under this agreement is capped at the lesser of amounts actually paid to the Referrer in the preceding 3 months or \$200. Savie is not liable for any indirect or consequential loss, including lost earnings or lost opportunity.

## 10. GENERAL

This agreement is governed by the laws of the State of Delaware, United States of America. The Referrer and Savie are independent parties — this agreement does not create employment, partnership, or agency. Savie may run other referral programmes on any terms it chooses. This agreement constitutes the entire understanding between the Parties on this subject and may only be amended in writing signed by both Parties.
